CALL TO ORDER - Chairman Eric Koreis called the meeting to order at 2:04pm. Roll was called via the web login.

1. Approval of November 1, 2023 meeting minutes and today's agenda*

2. Financial Report

A. Approval of Financial Reports (October 2023-November 2023)

Prior to the meeting all Region Council members received a financial packet including the Statement of Assets, Liabilities and Equities BARS Cash Basis, and General Ledger Detail Report for review which was prepared by the Plymale-Gillespie CPA office. In November the Executive Board pulled the CD funds out of the old CD (incurring an early withdrawal fee which is shown in the numbers below) and reinvested the funds in a new CD which will earn a much higher rate of interest.

5. New Business

A. Reinvestment of CD Funds

This was covered in the Financial Report above.

B. SW Region QI Meeting Report

April reported that the Region held a QI meeting earlier today. Dr Tracy Timmons was voted chair and there were cardiac data presentations by the Clark County Health District as well as from Amber Robbins from PeaceHealth SW. Amber also provided a case presentation. Anyone who is interested in joining the SW QI Committee should contact April.

C. Council Membership Recruitment

Eric has been working on recruiting new members to the council; there are now a few applications pending with the state for new members. Dr Macht will replace Dt Wittwer as the Urban MPD rep on the Council. The current council roster was included in the meeting packet as an FYI.

- D. Updating the Patient Care Procedures
 - A draft of initial updates to the region's Patient Care Procedures was included in the meeting packet for review. They will next be sent to the MPDs for their edits.
- E. Presentation of Certificates of Appreciation

We were supposed to have an in-person meeting today so Eric could present certificates of appreciation and small gifts to Dr Witter and Denise Haun-Taylor since they will be retiring from the Council this month; due to the snow, this presentation will need to take place at a later date. He thanked both for their years of service to the Council and their positive impact on the EMS community.

6. Preparedness Report: Marisa Hutcheson reported that the Region 4 Healthcare Alliance is continuing to recruit new members. On December 14th they held a communications exercise which had 100% participation. The Alliance is working on their response plan. Region 4 had many attendees at the recent national Healthcare Coalition Conference in Las Vegas. They will next meet in February at the Cowlitz Tribal Facility/online and will have a presentation on hospital capacity data.

7. DOH Report

Scott Williams reported that the legislative session has started; it will be a short, 60-day session. They are watching the following bills in the legislature: medical assistant EMT certification, ground EMS services, and newborn safe transfer. Rulemaking is ongoing. The Trauma Triage Tool guidance and related documents are now on the DOH website as is guidance for EMS and Naloxone. They are still working on WEMSIS rules. The DOH overdose dashboard is now live.

- 8. County Council Reports
 - A. Clark County: Their council will meet tomorrow. Dr Macht is their new MPD.
- B. Cowlitz County: They are looking at options for a protocol app. They are currently editing and updating their COPs. Their coroner will host a training for MCI incidents.
- C. Klickitat County: Sarah reported that they have 18 students in their EMT course. They purchased life jackets with their grant money. They are currently doing internal training.
 - D. Skamania County: No report.
 - E. South Pacific County: No report.

- F. Wahkiakum County: No report.
- 9. Good Of the Order/Public Comment: Denise joined the meeting and Eric thanked both her and Dr Wittwer for their countless contributions to the EMS system and for being leaders in trauma system.
